- THE HUNTSVILLE PRESBYTERY WAS CONSTITUTED on Monday night, July 15, 2019 with thirty-seven (37) ministers, and twenty (20) elder representatives. Friday, July 19, 2019 forty-eight (48) ministers and twenty-five (25) elder representatives were present. One (1) licentiate and two (2) YADs were also present. The Reverend James Childress prayed the Constitutional Prayer.

16. ADOPTED THE COMMITTEE ON MINISTRY REPORT

ADOPTED Recommendation #1: The Huntsville Presbytery affirm that the newly revised *CPCA School of continuing Education (SCE) Course Catalog* and the newly revised *CPCA Presbyterial Committee on Ministry Resource Handbook* serve as Huntsville Presbytery's current guidance. The HPCOM will request a time to present this to Church Session Representatives to include Pastors and Elders.

ADOPTED Recommendation #2: The Huntsville Presbytery affirm the CPCA SCE will assume the administration of **The Practicum** as approved at the 144th General Assembly, so that it will be standardized across the denomination.

ADOPTED Recommendation #3: The Huntsville Presbytery affirm the constitution section regarding no one is ordained unless they are called to a church or to a ministry approved by the presbytery, *Per Confession of Faith, Constitution 6.31: "Ordination is the setting apart of a licentiate to the full work of the gospel ministry. Since the ordained ministry is the highest ecclesiastical office of the church, presbyteries shall be careful to ordain no one until fully satisfied with his or her qualifications for so important a work. A licentiate shall be ordained only if he or she has a call to a church or to a ministry approved by the presbytery. Presbyteries shall not feel obligated to ordain a licentiate*

because of long tenure as such, nor continue him or her longer that there is promise of usefulness."

ADOPTED Recommendation #4: The Huntsville Presbytery affirm that the following Candidates for Ministry be licensed in the Summer Presbytery, July 2019: Sister Rosemarilyn Gibson and Sister Denieccee Pettaway.

18. ADOPTED HP COMMISSION TO NEW HEAVEN CPCA REPORT

ADOPTED the Recommendation that the Huntsville Presbytery Commission to New Heaven continues to work with New Heaven CPCA since it believes that its work if quickly nearing its completion with the church Session. However, there are a few areas that the Session, under the guidance of the Commission has begun. Specifically, approving the Pastor's contract, drafting Bylaws/Standard Operating Procedures (SOP), drafting a mission statement, and training on best practices for church recordkeeping/bookkeeping. The Commission will work diligently and expeditiously to assist with these action items so the church Session can again operate as spiritual and administrative leaders of New Heaven Cumberland Presbyterian Church in America.

Huntsville Presbytery Executive Board's Report: CONCURRED with the recommendations and the 2018 Congregational Reports. Recommendation #1 that the Huntsville Presbytery dissolves the Committee on Continuing Education because it duplicates many of the functions and responsibilities of both the Committee on Ministry (COM) and the School of Method (SOM). Recommendation #2 that each Huntsville Presbytery Auxiliary sends to the Presbytery the names of the delegates that were duly elected at their annual Summer Presbytery meeting before the close of the Presbytery on Friday. **Recommendation #3** that the Huntsville Presbytery Cumberland Presbyterian Youth Fellowship (HPCPYF) be realigned to the Committee on Christian Education (COCE) and that Bylaws for the Huntsville Presbytery Cumberland Presbyterian Youth Fellowship (HPCPYF) be written and submitted to the Presbytery for approval.
