**Organizational Matters**

1. **THE SPRING HUNTSVILLE PRESBYTERY WAS CONSTITUTED** with forty-one (41) ministers, and nineteen (19) churches. Seven (7) licentiates also answered the roll.
2. **RECEIVED** excellent hospitality from the host, St. Elizabeth CPCA.
3. **RECEIVED** greetings from the Moderator, The Reverend James Robinson, Sr.

4. **REFERRED** to the COM for authentication six (6) written communications from ministers who were not able to attend this meeting of Presbytery and two (2) verbal communications.
5. **REFERRED** to the BOB&F two (2) written communications requesting exemption from paying assessment and requesting permission to pay assessment in July at the Summer Presbytery.
6. **REFERRED** to the COM a communication from Lewis Chapel CPCA informing the Huntsville Presbytery that the Reverend Alvin Dean Johnson desires to become a minister in the CPCA.

13. **LICENSED** Sister Dominique Melton, Mt. Zion CPCA and Sister Jenary Rainey, New Hope CPCA.

15. **ADOPTED** the Huntsville Presbytery's Board of Budget and Finance Verbal Report.
